SCIF Election of Officers to be held January 23

Committee Chairs will be elected at the February Intergroup Business Meeting

Elections of SCIF Officers will be held on Monday, Jan. 23, 2012 during the Intergroup Business Meeting, 8 p.m. at St. Luke Lutheran Church. The positions to be filled include Chairperson, Vice-Chairperson, Treasurer, Recording Secretary and Registrar.

SCIF Officer Job Descriptions: Term length for all jobs is one year. Two consecutive terms are allowed. All officers are required to attend the SCIF steering committee meeting the second Monday of the month and SCIF general

business meeting the fourth Monday of the month.

Chairperson: Presides over monthly Intergroup and Steering Committee meetings. Maintains direct communication regularly with other Intergroup officers and committee chairpersons. Serves on ICSC. Must have general knowledge of A.A. Service Manual, Robert's Rules of Order and SCIF business procedures (for conducting Intergroup Business Meeting). Serves on the ICSC committee. Length of sobriety =

4 years. Average monthly time commitment: 8-12 hours.

Vice-Chairperson: Supports Chairperson in his or her duties; and fills in for Chairperson should he or she be absent or unable to perform that office. The Vice Chair should be informed in these matters: 1) Intergroup history and responsibilities; 2) current and pending business; 3) Chair's Rules – that is, parliamentary procedure as informed by A.A.'s Twelve Traditions. addition the Vice Chair runs the new rep orientation before the regular business meeting, gives the summation at the end of the meeting, and may be asked to liaise with other committees or to fill in for absent officers/committee chairs. Length of sobriety = 4 years. Average monthly time commitment: 8-12 hours.

Treasurer: Pays SCIF-related bills. Collects and records contributions from groups and works with bookkeeper in preparing monthly financial statements. Receives all monies collected at Alkathons and SCIF activities. Serves on ICSC. Accounting background helpful. Serves on the ICSC committee Length of sobriety = 4 years. Average monthly time commitment: 30+ hours.

Recording Secretary: Takes minutes at SCIF General and Steering Committee meetings. Delivers correct copy of minutes to Newsletter Editor. Length of sobriety = 3 years. Average monthly commitment: 6-8 hours.

Registrar: Maintains a list of groups and meetings available within the County. Keeps track on a monthly basis of which groups have representatives and how often reps attend meetings. Works with Outreach Committee to contact groups that are not active in SCIF meetings. Length of sobriety = 3 years. Average monthly commitment: 4-6 hours.

The SCIF Committee Chairs and Liaisons will be elected at the February 27 Business Meeting. **SCIF Committee Chairs & Liaisons Job Descriptions:** Term length for all jobs is one year. Two consecutive terms are allowed. Recommended length of sobriety, all positions: two years, All Committee Chairs are required to attend SCIF Steering Committee and General Meetings.

Activities Coordinator: Coordinates dances, summer picnics, and other activities and functions within Intergroup. Basically, puts the functions together. Must be able to delegate responsibility. Complete guidelines have been formulated for this service position. Average monthly time commitment: 20+ hours.

Alkathons Chair: Secures site for and coordinates organization of Thanksgiving, Christmas and New Year's Alkathons. Requires ability to recruit subcommittee chairs, delegate to them, and coordinate their efforts.

Communications Coordinator/Newsletter Editor: Collects articles, reports, and meeting changes for monthly Newsletter. Produces copy in format suitable for professional printing and

delivers it to the printer. Maintains list of current subscribers. Prints mailing labels; sends PDF version to email subscribers. Requires familiarity with image and page formatting software or interest in and ability to learn such software. Familiarity with Microsoft Office is necessary, particularly Word and Excel, as is a working knowledge of the English language. Maintains website. Coordinates efforts to produce Directories. Average monthly time commitment: 16 – 26 hours.

Outreach Chairperson: Checks attendance for registered groups. Checks with groups to encourage groups to participate in the A.A. community and Intergroup, so finding volunteers to attend meetings is necessary. Average monthly time commitment: 6-12 hours.

Seminars Coordinator: Determines what workshops the Fellowship is interested in. Arranges for speakers and/or panels; contacts participants; sets up time and room for meetings; gets information into Newsletter; encourages participation. Average monthly time commitment: 6-10 hours.

Teleservice Chairperson: Oversees day-to-day operations of Teleservice. Conducts monthly Teleservice business meetings. Average monthly time commitment: 8-10 hours. Usually elected on a recommendation from the acting committee.

ICSC Nominating Committee – Three members to be elected. Sobriety requirement – 2 years. Duties: “In April and October of each year, the Nominating Committee will present to SCIF not less than two (2) and not more than three (3) qualified individuals available to serve on the on the ICSC. Election will be by simple majority vote at that meeting.” Nominating Committee members shall elect a chair among themselves. Each member of the committee shall search for candidates for ICSC membership with the following qualifications: “individuals having sound business or professional backgrounds, at least five years sobriety, and substantial A.A. service experience. These individuals need not be members of SCIF.” It is suggested that Nominating Committee members meet together to discuss the qualifications of candidates they have identified and reach consensus on which individuals to present to SCIF as nominees for this position.

Nominating Committee members should be willing to review the workings of the ICSC and the suggested requirements for service on that committee. Several documents are available to provide that information.

What Is This Acronym, PI/CPC?

Public Information/Cooperation with the Professional Community. This is the service committee with the tongue-tying name and the longest acronym. In some areas they divide it into two separate committees doing two separate jobs. In Sonoma County we combine them for added fun and service.

In some areas this committee serves under the umbrella of Intergroup. In our County, PI/CPC serves under the General Service structure. Because of Tradition Four, A.A. is not a cookie-cutter structure. But this does make it hard for the regular A.A. person to keep track of all the differences and understand what is going on.

Public Information is the side that helps tell the public (non A.A. folks) what A.A. does and just as important, what A.A. does not do. Trained A.A. speakers will talk to the public, Drunk Driving Programs, schools, health fairs, clients of homeless shelters and any non-A.A. group that requests an A.A. speaker.

Cooperation with the Professional Community is the part of the committee that speaks with the professionals, making presentations to mental health workers, clergy, doctors, lawyers, judges, and any professional who works with the public. These are professionals that might come into contact with people who have a problem with alcohol.

If you are interested in being a trained speaker for PI/CPC, please attend the speaker training held at 7 p.m. at the employees lounge at Santa Rosa City hall on the second Wednesday of every month. The regular committee meeting is at 7:30 p.m. right after the training. Please come and join us.

- Young at hearts as well as younger in bodies! We encounter countless Millennium generation types at the treatment centers. Newcomers — especially — relate better with their own age group. Come to orientation Tuesday, January 17 at 6 p.m.

We receive 40 or more Blue Cards submitted from newcomers requesting contact each month.

Remember how we suffered from "pitiful and incomprehensible demoralization" and how some stranger took us by the hand to lead us to our personal miracle? We have the opportunity to share that miracle with the newcomer who is lost as we show — by our example — the path to freedom from our disease.


