### OFFICER REPORTS:

**Chair:** (Patty G.) Everything is going well. Discussed importance of following the process with regard to last months' motion. Apologized for not doing so.

**Vice Chair:** (Tina C.) Those new Reps. that didn't attend orientation should arrive by 7:30pm next month to attend the orientation, include phone number and email contact.

**Secretary:** (Jennifer R.) The General Meeting minutes of September 2013 were put forth and approved.

**Treasurer:** (Jimmie B.) Group contributions for September were \$3,336 more than September 2012. After expenses there was a gain of \$1,785. Bookstore income was \$5,962, and after expenses had a loss of \$969. Overall net gain of \$816.

**Registrar:** (Carolyn A.) Last month there were 230 groups offering 363 meetings per week in Sonoma County. At September's General Meeting there were 86 reps for 37% representation.

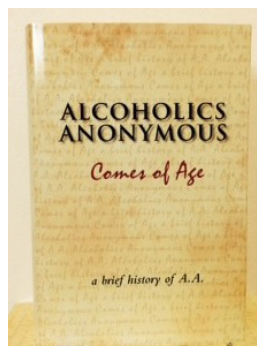

## Giving Back What was so Freely Given

My name is Tom and I'm an alcoholic and I am a member of the Bridging The Gap (BTG) Committee. The main purpose of BTG is getting people who are just coming out of a facility to their first meeting(s) on the outside. To do this takes a bit of work that is accomplished by people who volunteer their time to do service work. When I was new in sobriety I heard that service work will keep you sober and involved, and it was "suggested" that I find a service commitment. Over 5 years ago I attended a monthly BTG service meeting, took a commitment then, and I have been here in some capacity ever since. For me doing service work is a way for me to give back, and while I could never fully repay what was so freely given to me, I do what I can. Like most committees, we could always use more help. We are currently looking for both a women's and men's phone coordinator. Their job is to attend the monthly BTG meeting and to contact volunteers from the list to take people to meetings. We also need to fill two liaison positions. One is the liaison to H&I and the other is to PI/CPC. The job duties are to attend the monthly BTG business meeting and the monthly business meeting of either H&I or PI/CPC and give a short report at each meeting. If you are interested in a service position please come to our next meeting which is always on the 3rd Tuesday at the bookstore a 6:30 p.m. (6 p.m. for new orientations). It has been a pleasure to serve as the BTG Chair for the past months, but I need to step down and would like to welcome Linda W as the new BTG Chair here in Dist 12.

We provide updated literature to police stations, libraries, emergency rooms, senior centers, courthouses and the like. One of our services is to provide speakers knowledgeable about our recovery program to any institution desiring them. These speakers are A.A. members — former problem drinkers with some years of sobriety, and are well qualified to answer any questions about how alcoholics can recover in A.A. We would encourage younger members to get involved or anyone for that matter.

On the subject of younger speakers, it is my privilege to be serving as your current Schools and Juvenile DDP coordinator. Being able to share information about A.A. with these young people is truly as rewarding as it sounds. Typically we present to freshman at high schools, and I can assure you this is the class we all missed. The response from the students is remarkable, inspiring and gratifying. I will share with you our most recent schools presentation at Casa Grande High, where we were asked to speak with six classes in collaboration with our sister program Narcotics Anonymous. That's right N.A., and it was fantastic, each of us maintaining our Traditions and carrying the message of hope and recovery to a very alert bunch. The questions they asked us were eye opening. According to our GSO this is a first for A.A. to present at a school with N.A. Sonoma County leading the way once again.

If this kind of thing appeals to you, we encourage you to attend our meeting on the second Wednesday of the month at Santa Rosa City Hall in the employee lounge which is down at the lower level parking area.
