INTERGROUP OFFICER POSITIONS

Officers will be elected at the Intergroup meeting on January 25th.

If you are interested in a great service commitment step up and run for office. What better way to show your gratitude than to be available to serve Sonoma County AA?

JOB DESCRIPTIONS:

SCIF CHAIR

Responsibilities are to conduct the monthly Intergroup General Meeting and the Steering Committee Meeting, prepare agendas for those meetings and research background information for issues that may arise at those meetings. Experience conducting business meetings according to Robert's Rules of Order, SCIF business procedures, and AA Traditions is important. The sobriety requirement is four years.

SCIF VICE-CHAIR

Responsibilities are to welcome new representatives to Intergroup, assist the chair and be able to step into that position if need be. The sobriety requirement is four years.

SECRETARY

Requires showing up at two meetings each month – the SCIF General and Steering Committee meetings. The secretary listens carefully, takes notes, and then types them up for SCIF Officers and Committee Chairs. The sobriety requirement is three years.

TREASURER

The job consists of depositing group contributions, paying bills, overseeing the bookkeeping and financial reporting and serving as a member of the ICSC. The treasurer attends the 4th Monday SCIF General Meeting and the 2nd Monday SCIF Steering Committee Meeting. The 2nd Monday meeting is preceded at 6:30 PM by the monthly ICSC Meeting which the treasurer also attends. Minimum of four years sobriety and an accounting background.

REGISTRAR

Maintains a list of groups and meetings available within the County. Keeps track on a monthly basis of which groups have representatives, meeting changes and how often reps attend meetings. Works with Outreach Committee to contact groups that are not active in S.C.I.F. meetings. The sobriety requirement is three years.

SCIF COMMITTEE CHAIR POSITIONS

Elections for the Committee Chairs will be held at the February meeting.

Term length for all jobs is one year. Two consecutive terms O.K.) — Recommended length of sobriety, all positions: two years. All Committee Chairs are required to attend SCIF Steering Committee and General Meetings.

ACTIVITIES COORDINATOR: Coordinates dances, summer picnics, and other activities and functions within Intergroup. Basically, puts the functions together.

ALKATHONS CHAIR: Secures site for and coordinates organization of Thanksgiving, Christmas and New Year's Alkathons. Requires ability to recruit subcommittee chairs, delegate to them, and coordinate their efforts.

COMMUNICATIONS COORDINATOR/NEWSLETTER EDITOR: Coordinates efforts to produce and maintain monthly Newsletter and Directories. Conducts Communications meeting, works with Webmaster to keep website current.

OUTREACH CHAIRPERSON: Checks attendance for registered groups. Checks with groups to encourage groups to participate in the AA community and Intergroup.

SEMINARS COORDINATOR: Determines what workshops the Fellowship is interested in. Arranges for speakers and/or panels, schedules and promotes the seminars.

TELESERVICE CHAIRPERSON: Oversees day-to-day operations of Teleservice. Conducts monthly Teleservice business meetings.

HOSPITAL AND INSTITUTION COMMITTEE: Will S. – H&I needs speakers to go into facilities, please take back to your groups.

PI/CPC: Nick R.- No meeting this month.

SOCYPAA: Monique - Broomball event Dec. 5th.

ACCESS SONOMA COUNTY: Margie A. – Ad Hoc committee was appointed for the Dually Diagnosed seminar and will be ready sometime after January. Still determining what the best hearing devices might be. No meeting will be held in December. In January there will be a 15 minute orientation before meeting starts.

GENERAL SERVICE: Annie T. – They had a great California Northern Coastal Area assembly in Watsonville on November 7th. The focus of this assembly was to participate in the biannual Area Inventory. Total attendance was 341 members of CNCA. Of the 60 members that represented our District 12 (Sonoma County General Service), 34 were GSRs plus 1 Alternate GSR.

SPANISH INTERGROUP: Shaline E. – New Spanish meeting sheets available, please take back to groups.

UNITY DAY CHAIR: John F.- Called everyone who helped out to stand for a round of applause. \$246 in the positive that was split between Intergroup, General Service and H&I. Chair was a very rewarding position to occupy.

NEW BUSINESS : Presentation of New Business. Attention was directed to the Prudent Reserve Motion in agenda and in the newsletter. Pat H read the new motion out loud: "At the end of each year, after the prudent reserve is calculated and adjusted in accordance with the approved formula, any excess funds (operating reserve) shall be distributed: 40% to Sonoma County General Service (District 12), 30% to California Northern Coastal Area (Area 6) and 30% to AA General Service, New York." Sean M announced that this is the presentation of the motion only. Next month please bring back questions from your groups regarding the motion, and the month after that a vote will be taken to see if reps are ready to vote on the motion. Pat H explained why percentages chosen: Local first then excess funds will be passed on to New York. This follows the suggested percentages in the secretary's handbook. Pat then fielded questions from the floor.

Pat Introduced the SOCYPAA motion for Intergroup to write a letter of support to host the 39th ACYPAA Round up. Sean read motion. No questions from the floor. Pat made motion to approve. Unanimously passed and letter will be drafted.

And, in terms of the Professional Community, our members are available to give presentations to judicial, ministerial, medical and other professional groups—letting them know what AA is and is not.

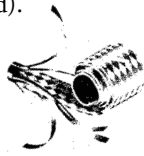
That sounds pretty impressive, doesn't it! I think so.

After considering many factors as objectively as possible, the Petaluma Hotline Steering Committee has arrived at a decision based, hopefully upon an accurate consensus of the Petaluma AA Community, to integrate services with the Sonoma County Hotline as of January 1st, 2010.

In a spirit of unity we will join with SCIF to provide 24 hour a day hotline service answered by alcoholics for our local community and all of Sonoma County.

A SCIF Hotline volunteer training session will occur on Wednesday, January 20th at 6pm here at our local Alano Club located at 1050 Petaluma Blvd No.

This training session will take place locally so that all current Petaluma Hotline Volunteers may immediately transition to SCIF Hotline as soon as spots are available.

A portion of our prudent reserve will be sent to SCIF immediately, and the balance will be forwarded in February after paying the final bills.

Thank you to all the folks who helped us arrive at this difficult decision. Thank you to all the groups that have contributed financially to make the local hotline possible, and especially thank you to all the volunteers who have kept the hotline alive, not only over the last year, but since its beginning.

My sincere hope, as your coordinator, is that this change is only indicative of a larger change already occurring in H&I, General Service, and Intergroup, to reduce the Cotati Grade down from its Mt Everest sized reputation, to a mere molehill standing between us and a stronger, more unified, AA fellowship.

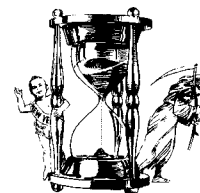

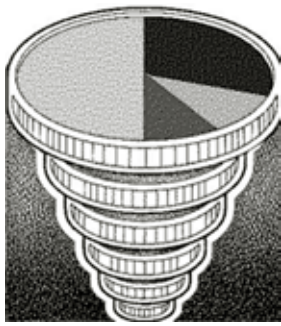
