Secretary: (Jennifer R.) The General Meeting minutes of November 2015 were approved.

Treasurer: (David B.) Group contributions were \$4,091; after expenses there was a net of \$712. Bookstore income was \$7,640; after expenses there was a net loss of \$5.00. Year-to-date income is \$15,466, which is \$8,392 more than last year.

Registrar: (Madeleine T.) In October there were 221 groups offering 344 meetings per week in Sonoma County. There are currently 117 groups that regularly send a rep to the General Meeting. There were 78 reps at the October meeting. New reps are encouraged to sign in on the correct day of the week (clearly marked). ELECTION OF INTERGROUP COMMITTEE CHAIRS

The election of SCIF Committee Chairs and Liaisons will be held on February 22 at 8:00 p.m. at the General Meeting at St. Luke Lutheran Church. You do not need to be an Intergroup Representative to be eligible to serve. Length of term for all Chairs and Liaisons is one year. Two consecutive terms are allowed. All chairpersons are required to attend the monthly Steering Committee and the General Meeting. Recommended length of sobriety is 2 years.

Activities Chair: Coordinates dances, summer picnics, and other activities and functions within Intergroup. Must be able to delegate responsibility. Complete guidelines have been formulated for this position. Average monthly time commitment is 20+ hours.

Alkathons Chair: Secures the site for and coordinates organization of Thanksgiving, Christmas, and New Year's Alkathons. Requires ability to recruit subcommittee chairs, delegate to them, and coordinate their efforts. Draft budgets for all three Alkathons, shop for supplies, and maintain a spreadsheet. Knowledge of Microsoft Word and Excel are helpful. Hold regular planning meetings for the Alkathons. Average monthly time commitment is 10+ hours.

Communications Chair/Newsletter Editor: Collects articles, reports, and meeting changes for monthly Newsletter. Produces copy in format suitable for professional printing and delivers it to the printer. Maintains a list of current subscribers. Prints mailing labels; sends PDF version to email subscribers. Requires familiarity with image and page formatting software or interest in and ability to learn such software. Familiarity with Microsoft Office is necessary, particularly Word and Excel, as is a working knowledge of the English language. Manages updates to the website and meeting directory, as well as directory printing. Average monthly time commitment is 15 to 20 hours.

Outreach Chair: Checks attendance for registered groups. Checks with groups to encourage them to participate in the A.A. community and Intergroup, so finding volunteers to attend meetings is necessary. Average monthly time commitment is 6 to 8 hours.

Seminars Chair: Determines what workshops the Fellowship is interested in. Arranges for speakers and/or panels; contacts participants; sets up time and room for meeting; gets information into the Newsletter; encourage participation. Average monthly time commitment is 6 to 10 hours.

Teleservice Chair: Oversees the day-to-day operations of Teleservice. Conducts monthly Teleservice business meetings. Average monthly time commitment is 8 to 10 hours.

Unity Day Chair: Selects a committee to help coordinate the event. Committee creates a theme. Submits a budget to Intergroup Steering Committee for approval. Organizes potluck, speaker panels, entertainment, raffle; creates and prints flyers.

ICSC Nominating Committee: Three (3) members are to be elected. Sobriety requirement is two years. Duties: "In April and October of each year, the Nominating Committee will present to SCIF not less than two (2) and not more than three (3) qualified individuals available to serve on the ICSC. Election will be by simple majority vote at the meeting."

ELECTION OF S.C.I.F LIAISONS

Liaisons do not attend the Steering Committee

General Service Liaison: Acts as liaison from Intergroup to General Service District 12, reporting at their monthly meeting news of interest about Intergroup. Average monthly commitment is 2 to 4 hours.

Hospitals and Institutions (H&I) Liaison: Acts as liaison from Intergroup to H&I Area 22, reporting at their monthly meeting news of interest about Intergroup. Average monthly commitment is 2 to 4 hours.

Spanish Central Office Liaison: Acts as liaison from Intergroup to Spanish Central Office, reporting at one of their weekly meetings news of interest about SCIF. It is recommended, but not required, that a bilingual male takes this position. Encourages them to send us a liaison. Average monthly commitment is 2 to 4 hours.

BRIDGING THE GAP
