Chair: (Sean McP.) Welcome everyone.

Recording Secretary: (Siobhan S.) March minutes were accepted as printed with no corrections.

Treasurer: (Shirley J.) Treasurers report for March 2010:

Group contributions of \$3,536 were very good for in February, more than the prior March by \$370, but less than the average of the previous eight years. Group supported expenses exceeded contributions by \$380, Bookstore expenses exceeded income by \$153 resulting in a \$533 net loss overall.

Registrar: (Rich S.) In March we had 350mtgs/wk, with 149 reps in attendance. 42% representation. Please make sure that you sign in, not everyone is. Also please make sure that you know your groups name so that I can have accurate records.

Bookstore Report: (Sean McP. for Linda M.) Linda is out sick. All is going well at the bookstore. All shifts are full. Reminder that the bookstore is now open until 6pm Mon-Fri.

Committee Reports:

ICSC: (Steve B.) this committee oversees the bookstore. We are making slightly less than our expenses. Since we are non-profit, we try to break even. We are also looking at a new computer.

Activities: (Kathy M.) New park for the summer picnic, which will be the first event. Have booked some speakers, it will be potluck. Halloween Dance is not booked, but would like to keep it in Santa Rosa. New Years Eve dance has been booked. Looking for other ideas of what people would like to do. Will pass around clipboard.

Alkathons: (Maureen C.) not present/no report

Communications/Newsletter: (Brian Z.) will update contacts on back page. Would love to get stuff from the fellowship to print

Outreach: (DeeDee S.) Sick. Not present/no report.

Seminars: (Doug S. for Karen M.) Next seminar will be on Wednesday, May 26th, 6:30-8pm at the bookstore, Prescription drugs in AA.

Teleservice: (Rob S.) we had a Quickie Committee mtg. 3 shifts open, Monday overnight 10pm-8am, Tuesday 8-10pm, and Friday 6-10pm. Discussed doing seminar, but decided to do a closed workshop for volunteers instead.

Liaison Reports:

BTG: (Cassie S.) BTG is a subcommittee of Gen. Service. We bridge the gap between Institutions, and AA meetings in the community. BTG does presentations in institutions, and has volunteers to take a person to their first meeting. I have brought yellow cards for reps to bring back to your meetings. PI/CPC: (Nick R.) Last month we distributed literature to jails, courthouses, and the like. PSA on TV last night. Speakers to DDP, but they have cut back. We have presentations coming up at the VA clinic, did presentation at Rotary Club last week, and will have a table at the North Bay Regional

Resource Comm.

SOCYPAA: (Billy S.) Events coming up: Toga Party at Petaluma Alano Club on May 1st, SOCYPAA elections on May 16th.

Access Sonoma County: (Margie A.) Access Sonoma County is sponsoring a workshop on dual diagnosis on Sunday, June 13th, (see flyer p2). 
