The Full Rewards of Gratitude

“Good day to you, dear reader ... here's a little something for you to think on - and hopefully enjoy! Something I've learned from my A.A. sobriety.

Has anyone told you today that you're appreciated? For me, and I'm sure for many, that's a special question, one I love to hear. And one I ask frequently, and always couch in the impersonal mode. (“Has anyone ...?” rather than “I think ...” elicits a much more positive response.)

Because, on the question of gratitude — a frequent topic of conversation at A.A. meetings — it occurred to me, some years ago, that I had been derelict in my attitude towards the subject: I determined to change my modus operandi, and have very much enjoyed the many rewards that decision produced.

The French have two sayings, which contradict/compliment each other: The one states “ça va sans dire — it goes without saying.” The other advises “mais il faut le dire - but it should be said.” And here's what I learned:

We're all thankful, and grateful to some degree, for much, most

of the time. And most of the time, we're barely conscious of it ... a pity, as we're missing out on an important aspect of our potential delight.

For it is only when we take the time, and the trouble, to manifest, to show, that gratitude, that thankfulness, by a spoken word, a gesture, an action, an appreciative glance, by a “way of being” in our everyday existence, that we fulfill the potential in those lovely feelings, that we reap the full reward available for them. So one should remember: “ça va sans dire, mais il faut le dire” — the little extra energy asked of us, the small personal investment that promises, and delivers, such a rich reward!

But wait — there's more! Scientists have discovered a strange, and somewhat miraculous, side effect, to the above acts of appreciation. There is an actual measurable lowering of blood pressure, and increase in serotonin production, for all involved in the interaction: for the giver, and the recipient. And even for anyone observing the moment! Amazing, no?

Third Legacy Procedure used to establish availability and vote taken. Voting will take place while reports are given. General Service reps will be counting ballots. 2012 Officers -- Chair: Steve B., uncontested; Vice Chair: Trevor H., uncontested; Treasurer: Jimmie B., uncontested; Recording Secretary: Patty G. 58 votes, Tina C. 18 votes on second ballot; Registrar: Carolyn A., 61 votes, Chris M. 15 votes on fifth ballot.

Officer Reports

Chair: (Sean McP.) Been fantastic to serve as chair. Learned a lot. A real honor and privilege.

Vice Chair: (Steve B.) Thanks Sean, been pleasure to serve with you and Shirley.

Secretary: (Patty G.) December 26, 2011 General Meeting minutes put forth and approved.

Treasurer: (Shirley J.) Group contributions were \$2,603 for December -- \$2,011 less than 2010. Group supported expenses exceeded income by \$634, Bookstore income exceeded expenses by 257, Activities expenses exceeded income by \$921, Alkathon income exceeded expenses by \$511, resulting in a \$787 net loss overall.

Registrar: (Jimmie B.) Last month there were 221 groups offering 344 meetings per week in Sonoma County; there were 57 reps at the December General Meeting for a 26% representation.

Bookstore report: (Linda M.) Year-end inventory went well with inventory cost differences below \$50. Thanks to all who helped count on New Year's Day. We've developed a new system for committee meetings held at bookstore in the evening. Chairs or alternates can come during the day and sign out the door key. All volunteer staff positions filled.

ICSC: (Steve Z.) December was one of best months ever for bookstore sales, grossing \$7,452, resulting in a positive bottom line. One month is not a trend, but it is encouraging. Approximately \$1,989 was from debit cards and \$564 from credit card sales. ICSC committee looking at ways to help bookstore be self supporting and need input from groups. First idea looking at is to charge for each copy of pamphlets instead of giving away the first five recovery pamphlets and one of the service pamphlets. Second idea is to carry a few of the popular and often asked for Hazelton publications. Would like to know what your group thinks. Please talk with any of the ICSC members about these two ideas.

Committee Reports:

Activities: (Tina C.) Learned a lot this year. New Year's dance came together. Takes a lot of time, effort and volunteers to put on activities. Looking at doing something different for next one, welcome ideas.

Alkathons: (Carolyn A.) Alkathons are done for 2011. Want to thank all the wonderful volunteers who made it happen. Sleepless nights but lots of fun. Good turnout for Christmas and New Year's Day and ended financially in the black. All supplies have been returned to the storage unit and pass it on binder is ready.

Communications/Newsletter: (Barry D.) New issue out, includes year-end financial reports. Thanks to committee. Feb. 22 next committee meeting – come join in. Next deadline is Feb. 17. Deadline schedule for all of 2012 now available. Committee proofing newsletter, discussing communication related items: style sheet, proofing guidelines, and potential schedule disclaimer wording.

Outreach: (Chris M.) Try to go out to meetings that don't have reps. Lots of fun. If you go to a meeting that doesn't have an Intergroup Rep, please suggest to secretary.

Seminars: (Diana D.) This Wed. is next seminar – Pass It On. Next seminar in March, topic to come soon.

Teleservice: (Steve B.) One open shift. Committee can use help. Contact on back of newsletter.

Spanish Central Office: (Ricardo M.) No report.

H&I: (Carolyn A.) Carries message of recovery into 23-plus facilities in Sonoma County, assist in Marin, Mendocino, Napa and Solano counties. Dec. we had no black outs (A.A. didn't show) but there were a couple of brown outs (facility locked down). Business meeting first Wed. at Community of Christ Church – please come.

General Service: (Michael Q.) Agenda Topics Workshop Feb. 18 at Bethlehem Lutheran Church. Forum for GSRs and district members to meet and hear from our Delegate, hear panel presentations, review the Agenda Topics and background information, and participate in mock sharing sessions.

Nine Words that Saved My Life

(Phone rings): "AA Hotline."

"Yeah, I need to talk to someone." Those nine words saved my life.

My disease loves memory lapses. Like the one I had in September of 2001 after 11½ years of sobriety. I had 10 years of good active fellowship and service until life got "busy."

I had started a new business and was doing well. I began to find myself going from three meetings and two service commitments a week to two meetings and one service commitment a week and eventually none. A year and half after my last meeting I forgot I was an alcoholic, had a drink, and proceeded to remain drunk for the next seven years.

For the next seven years my constant companions were vodka, shame, guilt, pain, loneliness and the Hotline. I now know that those calls made to the Hotline in the middle of the night were my tether to hope. Hope through kindness, patience, acceptance, honesty and no judging. For however long the conversations lasted I had a friend that understood me, and more importantly, was there.

With God's help, the Twelve Steps, the Fellowship and those late night calls to the Hotline over four years ago, God has blessed me with three and a half years of sobriety and the privilege to answer the phone and say "A.A. Hotline" and hear "Yeah, I need to talk to someone" and have another call to remind me.

Firstly, that my alcoholic mother died at the very young age of 61 from cirrhosis of the liver and other complications caused by her alcoholism. Secondly, my Irish great grandfather Francis died from injuries he received in a barroom brawl in the early 1900's. Alas, before coming to Alcoholics Anonymous I thought that they surely didn't have the luck of the Irish! But after being around the rooms and enjoying a sober lifestyle that is happy, joyous and free, I realized you don't need the luck of the Irish nor to catch a Leprechaun to find the pot o' gold at the end of the rainbow. We've found the pot o' gold right here in A.A!

We hope to convey this message when we make presentations to the

public and to professionals about what A.A. is and isn't, what A.A. does and doesn't do. When we provide this information to the public at DDP (Drunk Driving Program) classes, students at schools, health fairs and the like. When we provide this information to professionals such as Child Protective Services staff, probation officers, service providers to the homeless, judges, lawyers, and doctors, to name a few. We hope to save some lives each week through this wonderful service opportunity.

It is truly spiritually rewarding to carry the message in this different way. And that's no blarney! If you feel "lucky," we welcome you to check us out and share in this wonderful service! We meet on the second Wednesday of every month at the City Hall underground parking garage in Santa Rosa; 7 p.m. speaker training, 7:30 p.m. business meeting.
