OFFICER REPORTS:

Chair: (Patty G.) Everything is going great.

Vice Chair: (Tina C.) Those new Reps that didn't attend orientation should arrive by 7:30 p.m. next month to attend the orientation, include phone number and email contact.

Secretary: (Jennifer R.) The General Meeting minutes of August 26, 2013 were put forth and approved.

Treasurer: (Jimmie B.) Group contributions for August were \$3,629 which was \$335 less than August of 2012. After expenses, we had a gain of \$322. Bookstore income was \$8,770 and, after expenses, had a gain of \$982. Activities income was \$871, after expenses had a loss of \$389. Overall we had a net gain of \$915.

Registrar: (Carolyn A.) Last month there were 230 groups offering 370 meetings per week in Sonoma County. At August's General Meeting there were 72 reps for 31% representation.

COMMITTEE REPORTS:

Bookstore: (Jim W.- filling in for Linda M.) The Bookstore is in the process of training the new assistant manager, Glenn C. The Bookstore will now be selling "Dealing with Adversity in Sobriety." A four-part series for \$10. January through August 2013 sales have caught up to 2012.

ICSC: (Jim W.) Committee has hired the new assistant manager for the Bookstore, Glenn C.

Activities: (Lori S.) Halloween dance planning is going well. Next meeting is October 10 at 7:30 p.m. at Round Table on Occidental Road in Santa Rosa. Volunteer positions still needed.

Alkathons: (Richard H.) Meetings can now sign up for all three alkathons. Volunteers needed for set-up and breakdown at alkathons. Pick-up trucks needed for chairs to be dropped off. Alkathons are a safe place to meet new and old friends.

Communications/Newsletter: (Barry D.) New meeting directories are now available for the fall/winter; Intergroup Rep. is to carry the message back to the group

Outreach: (Ben G.) Went to six new meetings; four new reps. and nine new volunteers. Passed around list of unrepresented meetings so reps can sign up to visit one or more, and encourage group to get rep.

Unity Day: (Laurie E.) Info. is on front of newsletter. Remind groups this is a potluck. Dog on the Roof group is organizing potluck. Still need set-up and clean-up volunteers. Unity Day is the three entities, General Service, Intergroup and H&I coming together and members can learn about service to A.A. as a whole.

H & I: (Patrick W.) H&I carries message of A.A. to the confined alcoholic. They meet the first Wed. of each month at church on West Steele & Range in S.R. Orientation at 5:45 p.m., meeting at 6:15 p.m. Last month there was one blackout (H&I didn't show) and three brownouts (facility not allowing meeting). Currently there are 19 H&I meetings coordinated in Sonoma County.

Bridging the Gap: (Bill D.) BTG gets people to their first meeting from a facility. They need more volunteers, both to take people to meetings and to present at facilities. ICSC Nominating Committee: (Mike C.) ICSC is a three-person committee that oversees ICSC Bookstore. Position is for 18 months, and requires 5 years sobriety and a business background. OLD BUSINESS:

Motion: The NorCal Primary Purpose Group be reinstated into the AA meeting directory of the Sonoma County Intergroup Fellowship.

Comments from various meeting groups included: Tom G. (Outsiders Group) 21 in favor, 5 against, 5 abstained; Jude (Young At Heart), Questions re: if PPG took in 7th Tradition and do they contribute to General Service and Intergroup?; Nick (Sunday Big Book Review) read statement in favor for group; Houle (Bring Own Big Book) voted to reinstate PPG; Barry (Friday Vets) group voted no; John (Sat. Afternoon Winners) voted to reinstate PPG; Michael (Alcoholics Only) group voted 9-0 against. Sticking point was the affiliation with Texas; Veruna (Monday Speaker Mtg.) voted against; Lori (First Things First) voted to reinstate; Knoel (Old Timers and Newcomers) Knoel participated in PPG meeting. Group reads the Big Book and uses the study guide; Pete J. (Mature And Sober) voted against; Emily S. (Sunday There Is A Solution) group had no opinion; Emily S. (Step Sisters) to reinstate; Martin K. (Sebastopol Singleness of Purpose) 9-0 in favor; Heather (Chopstix) 2 in favor, 4 against, 7 abstentia; Mary O. (Step Sisters Sunday) Strongly in favor to reinstate; Zach (Realtime Discussion Thursdays) reinstate; John S. (Young People) reinstate; Mike C. (Attitude Adjustment) keep out; Holly (Redwood Winners) in favor of reinstate at steering committee, group split at meeting level.

Decision to take simple majority vote to reinstate Primary Purpose Group into the meeting directory. 53 voted to reinstate; 17 opposed; 9 abstentions. PPG will be reinstated into the directory.

NEW BUSINESS: None.

Living the Responsibility Statement

The mission statement of Access Sonoma County (ASC) is “to explore, develop and offer resources to make the message of Alcoholics Anonymous available to everyone who reaches out for it. ASC’s goal is to raise awareness of barriers and provide information and tools to remove or minimize those barriers. Example of barriers are impaired hearing, vision, mobility, wheelchair access, language difficulties, childcare, reading challenges.”

If you need signs to put in the front row for hearing impaired members – we have them. If you need a list of childcare meetings or meetings that welcome children – we have it. If a member needs a copy of the Big Book in Braille – we have it. If you need a Signing Interpreter for a deaf member – we can help. If you need someone who speaks Mandarin – we have it. And if we don’t have what you need to make your meeting accessible to all, let us know - we will get it.

The above is who we are. But there is one thing we don’t have and that is you. If you are interested in doing a little more to make the “I am Responsible” statement more than just 26 words come join us. We meet the second Thursday of each month. the next meeting is Nov. 14, at 6:30 pm at the SCIF Bookstore, 750 Mendocino Ave, Santa Rosa.

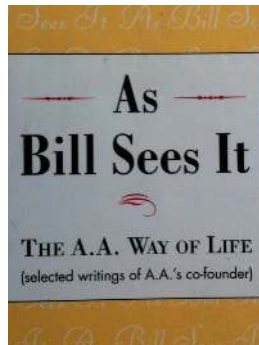

Staying in the Middle of the Herd

There is a sign on the wall of the Alano Club in Petaluma that says, “Alcoholism is a Disease of Loneliness.” This is particularly true for people leaving a jail, institution or treatment facility. They go from an environment where they receive round-the-clock supervision and/or support, to one where they are alone with a disease which is giving them messages like “it will be different this time” or “nobody will know.”

This is where Bridging the Gap enters the picture. Presently there are ten facilities in Sonoma County where our presenters go on a regular basis to describe to the residents the resources available to them. We show them a DVD aimed at providing an example of a newcomer’s introduction to A.A., share some of our own experience and answer any questions they might have. We then provide them with cards on which they give us their name, age, phone number, zip code, gender and discharge date, all on a strictly confidential basis. Within a few days of their return home they will be contacted by a volunteer from Bridging the Gap who will then take them to a meeting, introduce them to members of the Fellowship and do their best to make them feel welcome.

Service in Bridging the Gap can consist of providing companionship for newcomers at their first few meetings or doing presentations at facilities. If you are interested, please join us at our business meeting at the bookstore on the third Tuesday of every month. New volunteer orientation is at 6 p.m. followed by the meeting at 6:30 p.m.
