Have I Relapsed?

As I walked through the doors of my home group, a wave of apprehension swept over me. After a year and a half of sobriety, I again had to raise my hand and introduce myself as a newcomer. I had gone through the usual alcoholic emotions proceeding my relapse, anger, regret, and depression; however fear seemed to dominate me as I took my seat. The sea of faces was familiar to me, almost each and every one. I was active in my fellowship, attended many meetings weekly, held a couple of trusted service positions, have a sponsor, and sponsor other men. I thought that even though I hadn't drank, the decision to take double the dose of my prescribed medication, when I had not needed them, was just another facet of my alcoholism manifesting itself in yet another form of old behavior.

When the preamble had been read and the Serenity prayer recited, I tried to still my mind, but the usual stream of dialogue continued. I focused on the readings, and the peace of mind that I always find at a meeting, begin to filter through in the form of our sayings that can be found on the walls of almost any A.A. meeting place. "Easy Does It" seemed to speak the loudest to me, so I settled back and began to clear my mind of the thoughts that had distracted me for almost two and a half weeks constantly. Instead of beating myself up for what happened, I began to think of how my experience could benefit others. As "How it works" was read, the words "grasping and developing a manner of living which demands rigorous honesty" jumped out at me. When the tenth step was read, I felt it was most appropriate to my situation.

By the time that newcomers were asked to introduce themselves, I was more than relieved to do so. I had come to the realization that by making this simple admission I was in reality showing a room-full of alcoholics how to practice a principle - the principle of honesty in all our affairs. More importantly to me, I was becoming humble and remaining teachable. I realized also that I was never alone, and that fear is never real, because I was greeted and accepted with the same unconditional love that I was given as a newcomer, and as a member with considerable sobriety time.

After the meeting a gentleman with longstanding sobriety approached me and suggested that I might want to reconsider calling myself a newcomer technically because I hadn't drank. A lot of other folks said it is a judgment call. Now I am

a little confused. Is taking two pills that were prescribed to me considered an alcoholic relapse? Part of me wants to say no, I didn't relapse, but another part of me says that is an ego-based idea that should be put out of my mind. I know that I am not the only one who has ever faced this dilemma. This has been a problem for our fellowship for a long time.

Our singleness of purpose can be very confusing to someone with a dual diagnosis. I have also found that there are as many ideas about how an honest program should be worked as there are people in them. I gave up the need to always be right a long time ago and am always open to suggestions, but in the end I'm the one who has to live with myself, and the decisions I make. I make mistakes, and I suppose that sometimes I could even make a mistake about whether or not I made a mistake. What I do know is that with the program of alcoholics anonymous, the steps, a sponsor, and most importantly, a higher power in my life, I am blessed with being able to look at my behavior, and if I'm not sure about my actions, I have a whole fellowship of loving, caring alcoholics who will scrutinize them and gently suggest what I might want to change.

A.A. is a place where I can take my problems, my questions, and my solutions, and share them with others who are afflicted with my disease. Every meeting is an encounter with my higher power, and I always leave with a new perspective to ponder. Newcomer or not, I cannot stay sober until I am true to myself, and A.A. is where I learn to do that.

Toronto AA

"Welcome to Toronto, Kristina! Can I help you get where you are going?" that was a red shirted woman on the corner of the main street in Toronto, two miles away from the Convention Center, one of 2000 volunteers sprinkled like sugar on a donut all over the city of Toronto. Everywhere you looked, ate, walked, people watched, there we were. Red Shirts for local service people and countless thousands of happy joyous and frees with convention name badges, taking in the sights. The 70th International Convention "I AM RESPONSIBLE" hosted something like sixty thousand AAs and their families from over 90 countries for the most memorable experience in my sobriety (sober date, December 2, 2000).

Here are some of the highlights I'm happy to share: In a workshop entitled, Emotional Sobriety, an AA who had become a trusted companion of Mother Teresa brought tears to our eyes as she told why the candidate for sainthood (not an AA!) loved Alcoholics Anonymous.

AA seemed to help people with the only disease Mother Teresa could not cure with the gifts God gave her! When the AA declined wine at a bedside communion, Mother T squeezed her hand and thanked her for protecting something so precious. I AM RESPONSIBLE! At the opening ceremony, the first of over 90 flags paying tribute to sobriety in AA was a feathered walking stick carried by a sober Native American; the experience of one AA in India, sharing that in that country of 1 billion, over the past 40 years, AA has made inroads to the extent of 30,000 members in 800 meetings today.

Sober women are rare, as there is a great stigma, but they are there (noticed on the web a women's meeting in New Delhi, you go girls!); the awarding of the 25-millionth Big Book to the Warden of San Quentin; singing Amazing Grace with Judy C. (alcoholic folk singing hero of my childhood) and about sixty thousand others, and then the famous moment of silence, an entire arena, silent and grateful for the gift we have been lavishly given; at a meeting on AA in Africa and the Middle

East, one young AA was going back to Tanzania with 20 Big Books in Swahili to make his amends. He'd found a Loner in Zanzibar with 25 years, (he, in his mid twenties had 8) and they were going to give books out in hospitals throughout Dar Es Salaam. That's carrying the message! In a marathon meeting, hearing shares of other mothers from around the world who had left babies behind, reunited at last, in sobriety. We hear our own story and it gives us hope; and finally, at the last meeting, marking the 40th anniversary of the Responsibility Statement, given to AA in Toronto's last International Convention, 1965.

There were millennia of sobriety in that city; countless Steps taken on the Road to Happy Destiny. As we left the stadium after the final big meeting, a nonAA usher rushed up and shook my and said, "We're going to miss you." Thank you God for AA and for the constant opportunities it gives each of us to carry the message. I am responsible.

Sponsors, you've got to love 'em...

Our literature doesn't really give guidelines for sponsors. There isn't anything in the first 164 pages of the Big Book, or in the 12 x 12, either. What I know I learned from the sponsors I have had the privilege of working with over the 15 years of my recovery. I did what I have been taught, kept what I liked and left the rest behind. *Here is the way I work with others:*

I don't fish for sponsees. Like AA, I am a program of attraction. If a woman wants to work with me, she needs to ask me to help her. This is the first step, willingness. Once we sit down to talk, I explain that I expect her to call me, and I will call her back, but not initiate contact. I believe it is important for a newcomer to take charge of her own program from the beginning. And it is *her* program. I cannot keep anyone sober, not even myself; I rely on my conscious contact with God to maintain my recovery. While I expect her to find her own way to do her very important personal program, in the beginning, if she wants what I have, it might be a good idea to do what I did to get it: 90 meetings in 90 days, get a service commitment, establish a home group, and work the steps to the best of her ability. I also insist that she collect phone numbers of women she admires, in case I am not available, as I do have a life; if I didn't why would she want me to sponsor her?

Even so, I never tell a sponsee what to do. I suggest actions that have worked for me, and help her examine her motives in whatever action she decides upon. Even if I disagree, I honor my sponsee's decisions. It is more important to be kind than it is to be right, after all.

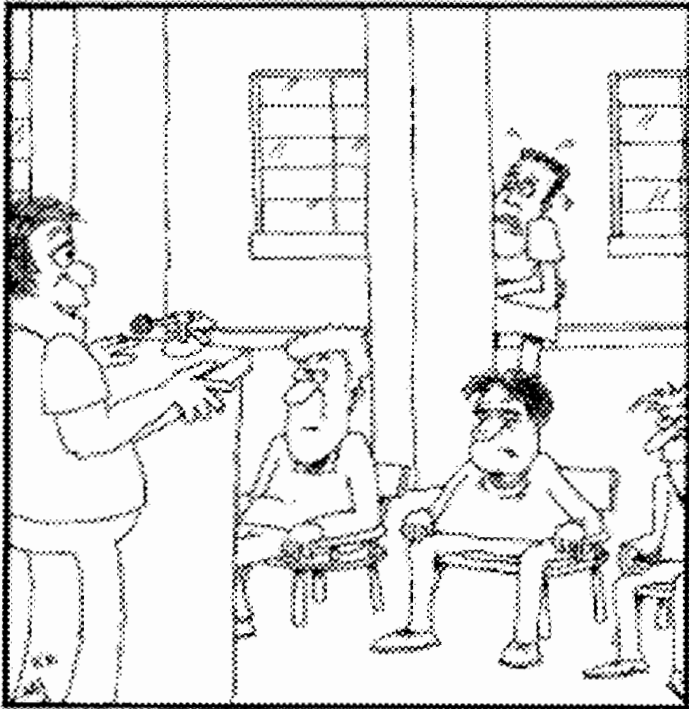
My recovery is the most important thing in my life. Everything else depends on it remaining healthy. Some effort is needed for that to happen. And I take it seriously. But I encourage my sponsee to take her *self* lightly, & learn to laugh at her self. Everyone falls down when first learning something new. I tell her, if an action feels uncomfortable, call me, and we will work it out. Even after we finish the steps together, my sponsee can call whenever she needs to talk. We are only as sick as our secrets. Talking about those things that make us cringe inside takes the power out of them. And whatever my sponsee tells me stays with me.

I have had five different sponsors in my sobriety. My first one and I came to an impasse and ended our relationship. I moved away, my sponsor moved away. And many sponsees have graced my sobriety as well. If they decide they need to move on, I bless them and wish them well. Sponsorship is not a popularity contest. It is a position of honor and trust. What I want most for my sponsee is whatever best serves her sobriety. And I receive so much more from this service than what I give. It is truly a blessing to be a sober woman, and know that I have something to give back.

General Meeting**

INTRO OF NEW REPS: Scott from Sunday How It Works at Newanga; Randy from Attitude Adjustment; Barbara from Daily Reflections; Jan from Wednesday Women's Step Study and Discussion; and Rachel from Sebastopol Sunday Nites.

August Birthdays: Charles 6 yrs, Tom R. 15 yrs, Victoria 2 yrs, and Greg 18 months.

Minutes of July 25, 2005, SCIF General Meeting were reviewed and then approved with one correction: Francis not Frances.

REGISTRAR: Deborah (absent)

H&I: Francis reported for Mark V. : H&I meets on the first Wednesday of each month with an orientation for folks new to H&I taking place at 5:45pm followed by the business meeting at 6:15pm.

GENERAL SERVICE: Kenin relayed the story of the phone call Bill made to Rev. Walter Tunks that set in motion the final stages of AA's founding that led to Bill's first call and meeting with Dr. Bob that eventually led to the founding of Alcoholics Anonymous. A voice recording of Bill's recantation of this story is available on file at the General Service Office Archives. G.S.O. is dedicated to discovering AA's roots and growth around the world. Our Area Archives do the same within the California Northern Coastal Area as do our District Archives within Sonoma County. Watch for the Archives displays at the upcoming Unity Day which will occur on November 5th at St. Mark's Church on Mayette Ave. in Santa Rosa.

PI/CPC: Dave: Dave indicated that they meet the 2nd Wednesday of each month at SR City Hall Lounge w/ speaker training at 7:00pm and Business meeting at 7:30pm. He explained that the function of this committee and that they have been distributing literature to hospitals, police stations, senior centers and the like. Currently distributing copies of Living Sober and the Big Book to local libraries.
