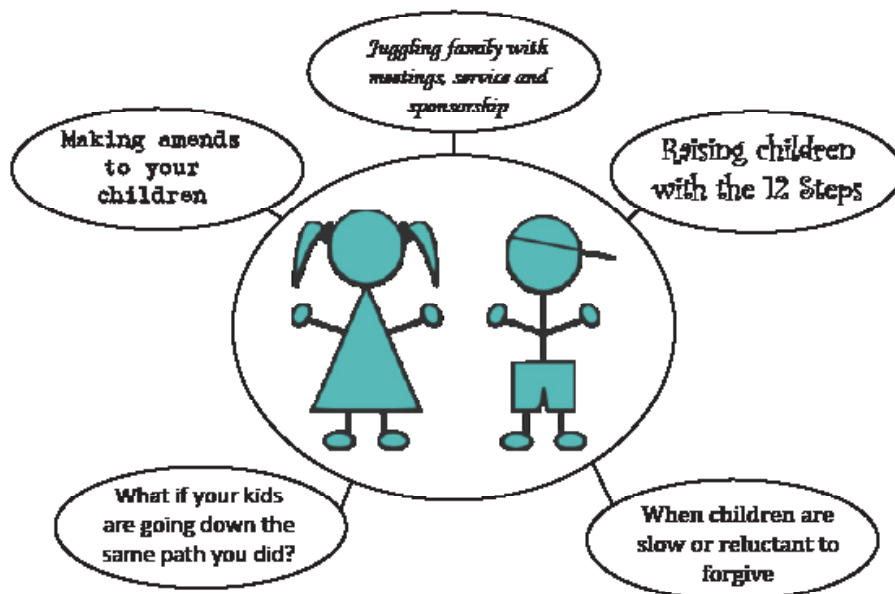

BRIDGING THE GAP

It was late in the summer some years ago when the court appointed me to a treatment facility and to A.A. I knew of Alcoholics Anonymous but I did not really know what A.A. was about. I had never been to a meeting before and I was scared and nervous.

I went into the treatment facility, and I remember a man and a woman from Bridging the Gap (BTG) coming in and explaining what A.A. was and what A.A. was not, and offered to connect us to someone who could give us a ride to our first meeting in our home community. They relieved my mind, because for some reason I had thought that A.A. was a cult. After they spoke to us I had many questions about A.A. and how it pertained to me. My biggest question was: "When will I be done with the program and how long will it take?" I was shocked to learn that I have a disease and would have to do it for the rest of my life. I would always have to be working the program if I wanted to stay sober. At the time I can remember a lump in my throat thinking about having to do this for the rest of my life. Because of those two presenters that day, it stuck with me how wonderful this could be.

Today, I have become a presenter for BTG and I am happy, joyous and free from the bondage of alcoholism.

PUBLIC INFORMATION / COOPERATION WITH THE PROFESSIONAL COMMUNITY

Many A.A. members are familiar with this branch of General Service, and most know that we provide speakers to classes of the Sonoma County Drinking Driver Program. In fact, it was one of those Public Information/Cooperation with the Professional Community (PI/CPC) speakers who, years ago, convinced me to give sobriety a try.

PI/CPC also provides speakers to a number of local schools, a service equally important if less well known. Our presentations are typically made to high school freshmen and, as you might expect, student reaction is mixed. Some kids don't hear a word we say; a fact that is often true of adults as well. But the few who listen make it all worthwhile, and there are some of those in every class.

At some point we ask the kids if anyone knows an alcoholic. I'm no longer surprised when nearly every hand goes up, but it's the facial expressions that shake me. I've seen everything from amusement to anger. And I've seen a whole lot of shame and disgust. My own daughters would have had the same expressions when they were that age, a knowledge that will always haunt me. PI/CPC service is one way I make amends, and I always get back more than I give.

If this service interests you please come to our committee meeting and check it out. The committee meets on the second Wednesday of every month at 7:30pm in the Santa Rosa City Hall employee lounge. Speaker training is held at 7:00pm before the meeting, and your interest and participation would be most welcome.
