## **TELESERVICE**

### Statement of Purpose

Sonoma County Teleservice is a group of alcoholics who answer the local AA Hotline 24 hours a day, seven days a week. Calls to the Hotline range from requests for meeting information, general information about AA, people who want to stop drinking or are afraid they will drink. Hotline volunteers are given training and guidelines to assist them in handling calls. Calls beyond information about AA meetings, which may involve personal discussions about the benefits of continued sobriety within the AA program, are referred to 12th Step volunteers.

### How do I get involved?

We invite any AA member who is interested in getting involved in Teleservice Hotline or 12th Step work to attend our business meeting on the 2nd Tuesday of the month at 6:00 pm at the Bookstore.

## Dana M. PI/CPC Committee Shares

Public Information and Cooperation with the Professional Community is a sub-committee of General Service, District 12, Sonoma County. We are the public face and voice of Alcoholics Anonymous. We need recovering alcoholics to share their experience, strength, and hope in public venues, such as the local drunk driving program, local schools, veterans' groups, doctors, nurses, social workers, law enforcement agencies, the courts, public libraries, psych emergency services, and any public group. These organizations offer us the opportunity to provide a speaker to help them better understand what A.A. is (and isn't), where their students, clients, or patients might find out more information, and where and when to find meetings.

I've had the privilege of being the Schools and DDP/Young Offenders Speaker Coordinator for PI-CPC since I came on, mid-panel, in August 2019. In the six months before the world changed in March of 2020 I spoke to dozens of fellow AAs in order to carry the message, the PI-CPC way, to approximately 700 Sonoma County high school (and one middle school!) students. Some of those kids may indeed already be suffering from alcoholism. And if they aren't, we hope to plant a seed if they should ever need to know where to go for the solution. That probably sounds like a lot of phone calls on my part. But I'll tell you what: never have I made so many calls in which the recipient was always happy to hear from me. I settle in with my coffee, my PI-CPC list of alcoholics (just like you) who happen to have a) attended our easy 30-minute training, and b) observed a presentation in action. I make my calls or my texts and I have that experience Bill touches on in the Big Book. There's an almost instant camaraderie much of the time. We're all happily working, one day at a time, on continuing to not just survive that shipwreck, but finding joy in service.

And then everything went dark for a while; the world learned how to carry on work and school from home, online. Then in October 2020 one of our local schools reached out. Can we do what we do... on Zoom? Well, why not? Meetings had sprung up on Zoom all over the world.

Nearly all my contacts were willing and able to do their thing for the schools using the Zoom platform. Some commented that it was even easier, more convenient. Some lamented the inherent lack of the kind of connection we were also missing in our meetings since going online. The two schools who had us over Zoom were thrilled.

An unanticipated bonus was the ability for the students to share their anonymous feedback, en masse, thanks to screen-sharing that the teachers provided. The Zoom environment actually, in my observation, managed to make for a more connected, more intimate experience in some ways. Last week we received a request from an area school to give a total of 6 presentations in late September. In person. It's been 18 months since we were last able to do that. We will plan for in-person, and pivot to Zoom if we have to. One way or another we'll get the message through wherever we are invited.

PI-CPC meets on the second Wednesday of every month, currently on Zoom. Meeting ID 961 8127 1048, password Dist12GS. Pop in at 7pm and attend the speaker training and stay for the committee meeting that runs from 7:30-8:30. Being a speaker will fit into any schedule. We have both daytime and evening needs. # Bridging the Gap

## Statement of Purpose

Bridging the Gap is a General Service sub-committee that supports that very important first step for alcoholics who have just been released from a hospital, treatment center or correctional facility. By providing a temporary contact, Bridging the Gap helps newcomers make the transition to Alcoholics Anonymous in his or her home community.

Members of Alcoholics Anonymous, usually in pairs, meet the patients or inmates after release and accompany them to their first A.A. meeting. As in all 12-step work, this activity is strictly voluntary.

## What Positions are Available?

We're always looking for volunteers to fill our phone list. When someone requests our service, we provide them with a volunteer to take them to their first A.A. meeting. We try to have a volunteer available who is someone around their age and gender, who lives in their neighborhood, who can take them to the volunteer's home group, introduce them to the fellowship and make them feel welcome and at home. It is usually a one-time commitment, and as in all 12-step work, should be done in pairs. To be a volunteer, it is suggested that you have at least 6 months sobriety and a working knowledge of the twelve steps.

There are also service positions available on the committee. These service positions include chair and alternate chair positions, recording secretary, phone coordinators, Intergroup liaison, H & I liaison and presentation teams.
