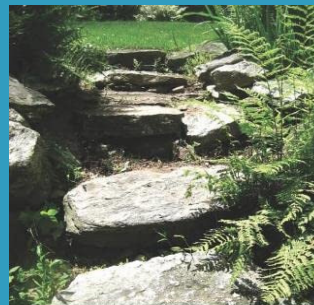

## GENERAL SERVICE

Service is a cornerstone of our program – one side of the triangle, along with Unity and Recovery. But what does it truly mean to serve in Alcoholics Anonymous? Service, in its simplest form, is about the giving of oneself in order to help others. It is the act of reaching out and offering support, compassion, and understanding. However, the beauty of service within AA is that it's not only beneficial for those we help, it also helps us cultivate our own self-esteem and emotional sobriety as well.

In AA, the role of service can range from being a greeter at meetings, to coffee-making, to more involved roles like Secretary, Intergroup Rep or General Service Rep. These positions ensure the smooth running of our groups, while also providing vital structure and continuity. Where Intergroup helps foster the connection of the groups within our community, General Service keeps these groups connected at the national and worldwide level.

But why should we serve? First and

foremost, service helps us maintain our sobriety. It reinforces our commitment to the program, reminding us daily of the value of our recovery. Serving also gives us a sense of purpose. It actualizes the idea that we are part of a larger community, and that our actions can positively affect others. It can be a primary vehicle for experiencing relief from the bondage of self.

There is also a hidden gem in service that can be easily overlooked: it teaches us invaluable life skills. Through service, we learn responsibility, teamwork, patience and leadership. We learn to listen more and judge less. It can help us break free from the self-absorption that often characterized our drinking days, by opening our hearts to others and giving us an opportunity to show up in a new way.

However, it's vital to remember that service isn't about self-sacrifice or becoming overwhelmed. We must always be aware of our capacities and boundaries (this is where our Sponsors and Service

Sponsors can be especially helpful). When it begins to feel like an obligation or a burden, we can ask whether we are truly taking on too much or simply falling victim, yet again, to our own selfish concerns. It can be all too easy to overextend ourselves with the best of intentions, and easier still to forget that our true purpose is usefulness to others, that we are here to ensure a seat for the future alcoholic, and that our own sobriety is largely a matter of grace rather than our own resourcefulness.

At its core, Service goes hand in hand with Unity and Recovery (quite literally, at the end of most meetings). It is the embodiment of the spirit of AA – one alcoholic helping another. It is one of many paths to freedom in Alcoholics Anonymous and remains a beautiful reminder that we don't do this alone.
