## General Service Corner: "Pass-It-On"

This time of year in alternating years, our people in General Service start working on the documents we call the "Pass-It-On." A simple version includes what worked, what didn't work and what you wished you knew. They really help for meeting service positions as well.

Writing up a Pass-It-On is an act of humility. I need to walk that line between 'everybody can do this I shouldn't have to write it down' and 'here's the only way you'll survive in this service position.' It's an opportunity for reflection on how much I've learned and embodied without realizing it. I can take appropriate stock of evidence of my effort and growth. I may also be able to help someone step into a service position that has challenges I can't see or ever know about. Some people learn differently and a written pass-it-on may not be enough. Some discussion or a follow-up session might help if they want. Perhaps a performance art piece is the ticket.

I was involved with plenty of passing when I was actively drinking. I passed the bottle (I likely had my own stash somewhere too). I took a pass when it was time to own up to a stupor-induced error. I passed out. I watched friends and family pass away. I passed on caring for myself.

As I'm headed down the home stretch of District Committee Member, I can also be grateful for the pass-it-on I was given. I'm going to be cutting and pasting quite a bit. My Pass-It-On for the subdistrict 09 West County will be a gentle pat on the back for myself and an offer to support. And then I let them mess it up anyway they want. I learned that from my sponsor.

All you GSR's who might be eligible to be a DCM, go for it. There is a map and lots of help. It is a great service position. We get to participate in the even bigger Pass-It-On to do what is possible to ensure that our AA program is available to generations of alcoholics who will need us to pass it on. — Maureen G.

Shortly before I became sober, a neighbor gave me a metal tin filled with pencils and pens. That small gesture was all the encouragement I needed to acknowledge my passion for art and begin creating art. A few random classes over the years improved my skill and eventually led me to find my current love of acrylics. This would have never happened if I had still been drinking.

As I approach a new painting, I start with a photo of something that evoked wonder and awe within me. I am always amazed how the photo has so much more to show me than I first observed. Somehow I am given new eyes to see the light and shadow through the process of painting. When I begin inserting the lake and trees, I notice there are berry bushes with blossoms near the lake. I see how the details I paint from the natural world reflect my own life. And just like recovery, it leads me to gratitude.

Art making and recovery have taught me there is so much more to life than what I see initially. The fullness of the gift presented to me at any moment seems to always reveal more when I reflect and ponder on what is before me, like the dark green water that so wonderfully highlights the small outcropping of gray jagged rocks near the shore and add interest and beauty to the full picture. So I have learned that the peripheral people and smallest elements of my life, even the challenging ones, all contribute to the beauty and richness of my blessed life.

### This is Whi I Serve \*

My first experience with Sonoma County Intergroup Fellowship (SCIF) was the Thanksgiving Alkathon in 2014. I had close to four months sober, had little contact with my family, and didn't know how to stay sober through a holiday. I signed up to help in the kitchen. I met a lovely lady who had years of sobriety. To this day, I cannot recall who she was. What I do remember is that her joy made her appear as though she was dancing around the kitchen as she heated food, washed dishes, and chatted with me. As soon as I was eligible, I signed up to be an Intergroup Representative. I joined the Alkathon Committee and oversaw selling drinks. This felt important! SCIF gave me a responsibility and a purpose;

it also distracted me from my strained family relationships. This is why I serve, to forget about myself for a while.

Throughout the years, I continued to help with the Alkathons. Staying up late, waking up early, laughing with my friends, and praying in the halls with the suffering alcoholic. This is why I serve, to be able to reach another Alcoholic.

I have been on the SCIF Committee in one capacity or another for more of my sobriety than I haven't. I have been taught how to run a business meeting, take a group conscience, listen to opposing opinions, see the greater purpose, and laugh with my friends along the way. My life has changed because of being a part of the Committee. I have learned how to show up, that the definition of commitment has nothing to do with "if I feel like it" or not, that Sonoma County AA always shows up, and how to be an adult.

I have grown up because of this service. I met my husband because of this service. I get to be a sober Mom because of this service. This is why I serve! Service has enabled me to think of others and forget about myself, to grow in ways I wasn't aware needed growth, to commit to something greater than myself, to have a purpose, and to connect with others. I am forever grateful to AA and Sonoma County Intergroup Fellowship for giving me the life I have today!

### The Alkathon Lottery will happen at the September 23<sup>rd</sup> Intergroup General Meeting, so *it's time for groups to discuss if and when they would like to host*. The Alkathons have returned to 1495 W Steele Ln., Santa Rosa! They all start at 6:00 pm on the eve of the holiday and end at 10:00 pm on the holiday. The last meeting slot is 8:00 pm. Alkathon meetings can be hosted in person only. Not on Zoom.

### How the Lottery will be run:

- Intergroup representatives must be present in person (not on Zoom) to make their selection.
- Baskets decorated for Thanksgiving, Christmas, and New Year's Eve will be on a table. When they arrive, reps fill out forms and place them in basket(s) of the Alkathons their meeting would like to host. If a meeting only wants to host for one of the Alkathons, the rep places a form only in that basket.
- The lottery starts with Thanksgiving. The first ticket drawn selects the meeting time they want to host. Tickets are drawn until all meeting slots are filled. The same procedure will be used for Christmas. If a meeting had already been selected for Thanksgiving, that ticket will be skipped and another one will be selected. And the same happens for New Year's Eve. Meetings already selected for Thanksgiving and Christmas will be skipped. This procedure ensures that all meetings will be able to host an Alkathon meeting and multiple slots will not be hosted by the same meeting. If slots remain open at the end of the lottery, then meetings can sign up to host a second Alkathon meeting.

### **ICSC Commettee Members Sought**

The Intergroup Central Service Committee is a management and oversight committee specifically charged with the responsibility to set the policy, regulate the affairs and oversee the operation of the Sonoma County Intergroup Fellowship (SCIF) Central Office, also known as the Bookstore. It advises the Steering Committee on matters affecting SCIF's status as a non-profit corporation, making sure that state and federal government regulations are followed and regulatory filings are completed as required. As such, it fulfills many of the functions cited as responsibilities of "Board of Directors" in the California Corporations Code.

The Sonoma County Intergroup Fellowship will be holding an election for a new ICSC committee member at the October general meeting, Oct 28<sup>th</sup> 7:30 pm, at St. Luke Lutheran Church, 905 Mendocino Ave., S.Rosa. This election is held twice a year, April and October.

- Active participant in Alcoholics Anonymous\*
- Working knowledge of the 12 Steps and 12 Traditions
- Retail/general business management experience and/or operational management experience
- Working knowledge of financial statements
- Human resources & non-profit experience and/or knowledge preferred
- Prior experience on other professional boards a plus!
- Must be PC-literate with experience with MS Word and Excel. Intuit/QuickBooks is a plus!
- 18-month commitment

### Job description:

- The ICSC is a rotating body of five members two SCIF officers (the chair and the treasurer) and three at-large ICSC members elected by the intergroup representatives.
- Secretary: First Term Member, records minutes for ICSC meetings
- Vice Chair: Second Term Member
- Chair: Third Term Member, leads meetings

Committee members are required to attend the ICSC Steering Committee Meeting on the 2<sup>nd</sup> Monday of the month at 6:00 pm, as well as the SCIF Steering Committee meeting right after, from 7:00 until 8:30 pm at the Bookstore (750 Mendocino Ave.). Committee members are also required to attend the SCIF General Meeting held on the 4<sup>th</sup> Monday of every month, 7:30-8:30 pm. Other requirements include work on special projects, including a yearly Bookstore Inventory. Monthly time commitment estimated at 5-10 hours per month. ### July 2024 Treasurer's Report

The Bookstore income for June 2024 was \$8,960. Cost of goods total was \$6,022. Total expenses for July were \$3,549, for a subtotal loss of \$611.

Central Office income for July 2024 was \$7,685. Total expenses for July were \$4,340, for a subtotal gain of \$3,416. Entergroup Activities income for July 2024 was \$839. Expenses for July were \$0, for a subtotal gain of \$839. Overall for July, there was an overall gain of \$3,632.

Year to date our income is \$107,291, total cost of goods is \$42,598, and our expenses are \$58,750 leaving an overall gain of \$5,952. in service, Holly Hulsey


