



I was broken, hopeless. I had exhausted all my options, all the things that I thought I should do; there seemed to be no way out. I had two options: one was driving into a redwood tree on the way to work, the other was to go to a meeting of Alcoholics Anonymous. Thank God I chose the latter.

While going to meetings, I realized I could not do this on my own, I needed a sponsor. I was gifted with an exceptionally astute man. The first thing he asked me to do was to help the newcomer that had one or two days, or a week less than me. That seemed almost impossible since it was all about me. As we began the steps he slowly and methodically helped me realize that I wasn't the only one on the planet. So, in order to get out of myself, he taught me how to help others.

As the fog began to clear, and I completed my steps, not only did I engage with new sponsees, but he also showed me that there were other things greater as well, not only the health of our sponsees, but the health of AA as a whole was paramount.

I first began five years with H&I, and yet there was more to be done. I began as a General Service Rep for a meeting I was attending. I was introduced to the Twelve Concepts of Alcoholics Anonymous. I realized that Bob and Bill had entrusted the health and well-being of Alcoholics Anonymous, both in the present and in the future to all of the Fellowship, the 126 thousand registered groups of AA Worldwide. That means that each group has the responsibility through the Agenda Topics process for the decisions that matter to the present and the future of Alcoholics Anonymous, and thus continue the legacy of reaching out to the alcoholic who still suffers.

I have felt deeply honored to be a part of General Service and this process, and have realized that not just my opinion, but the opinion of every group and individual matters. If this is something that calls to you, come join us. We will meet you in the sunlight of the spirit.

Vice Chair: (Bruce W.) No report

Secretary: (Megan M.) Minutes are accepted and approved from September.

Treasurer: (James B.) The Bookstore income for September 2024 was \$7,561.73. Cost of goods total was \$4,834.13. Total expenses for September were \$3,013.80 for a subtotal loss of \$286.20.

Office income for September 2024 was \$5,482.80. Total expenses for September were \$4,378.01, for a subtotal gain of \$1,094.55.

Intergroup Activities income for September 2024 was \$1,710. Expenses for September 2024 were \$2,818.86, for a subtotal loss of \$1,108.86.

Overall, for September, there was an overall loss of \$300.51. Year to date our income is \$140,015.65, total cost of goods is \$53,753.95, and our expenses are \$76,874.97 leaving a gain of \$9,386.73.

In the August report the "total cost of goods was reported as \$76,352" it was actually \$48,919,82 all other reported information reported was correct.

Registrar: (Ellen W.) As of September 2024 there were a total of 237 groups here in Sonoma County offering a total of 418 meetings each week. There were a total of 95 reps in attendance and 8 were new. Reps: Zoom 19, In-person 44, New reps 8. Meetings: Zoom 120, In person 275, Hybrid 24.

COMMITTEE REPORTS

ICSC: The ICSC (Intergroup Central Service Committee), a subcommittee of Sonoma County Intergroup Fellowship, provides oversight of the Bookstore and supports its paid Manager. ICSC members are elected twice a year at the Intergroup meeting. Candidates must have five years of sobriety, business or professional background, and substantial AA service experience.

Bookstore: (Bob F) Bookstore Report to the Intergroup General Meeting October 28, 2024. The Bookstore sold 314 AA books in September. We currently have 72 pre-purchase orders for 156 copies of the Plain Language Big Book, many from an unprecedented and unexpected 17 states outside of California. We didn't plan this. The online store became one of the top 5 google search hits made by AA members, Again, prepurchasing is just a convenience, there will be plenty of these on hand once our order comes in mid-November Then we received an email from a Carrie in New Orleans." A vote is needed to determine whether we should continue to sell the non-conference approved literature in the bookstore. The literature consists of: Drop the Rock, 24 Hour Hazelden, New Pair of Glasses, The Little Red Book, and some Al-Anon books.

SCIF kindly requests each meeting gather their group conscience and take a vote at the meeting level (typically for multiple consecutive meetings, not just one.). Directions for how to take a group conscience is outlined in the New Representative Guide and on the Website. THE INFORMED GROUP CONSCIENCE

As stated in Tradition Two, our sole authority is "a loving God as He may express Himself in our group conscience."

The late Dean K., past Delegate from California Northern Interior Area, said there are two ways to arrive at a group conscience: "The competitive way permits the person with the loudest voice to push his ideas across, take a vote and come up with a 'majority' decision. This is not informed group conscience. In the cooperative way, group members come together in mutual trust to arrive at a group decision, not one individual's personal triumph."⁴

What is an informed group conscience and how is it achieved?

"The group conscience is the collective conscience of the group membership and thus represents substantial unanimity on an issue before definitive action is taken." This.... "implies that pertinent information has been studied and all views have been heard before the group votes." 5

"...in keeping with the best tradition of A.A., we find that whatever 'authority' exists is first expressed in the group conscience — then passed along...all functioning within the framework of (The) Twelve Concepts (of World Service)."6

This reminds us that Concept One states "the final responsibility for A.A. World Services should always reside in the collective conscience of our whole fellowship." No one person or group should make our decisions for us, no matter how persuasive they may be. As stated in Tradition Two (short form) "...Our leaders are but trusted servants, they do not govern."

"Not always understood, Group Conscience as expressed in Tradition Two is a powerful spiritual concept that makes it possible for people of diverse backgrounds and temperament to rise above personal ambition and unite in a common purpose; to stay sober and extend the hand of A.A. to the alcoholic who still suffers."
